1. Old Business:

a) T-shirt update:

Stacy G reported that the vendor is agreeable to mixing up the order with different size t- shirts. The committee discussed color options for the shirts and the print as well as different logos to put on the t-shirts. KD will order a total of 100 t-shirts.

Motion by Stacy D for 2 different color t- shirts. 1 bright color shirt for all volunteers and another that is gray with black print to sell. In addition the shirt logo will be Kingston +post mark second by Lori . All in Favor =7 Opposed =0 Abstained =0 .

Action Item: Stacy G to send Stacy D High range vendor contact information.

Action Item: Stacy D to provide High range with the number of t-shirts in each size.

Total cost=700.00 for 100 shirts.

b) Scare Crow contest update:

Glenn also noted that the Bakie school has requested that the fireworks not be set up until after 4:30 pm on Friday.

The committee discussed the updates needed to the Electricity on the plains.

Roadside Diner was requesting a 50 amp outlet for the duration of Kingston Days although the diner is participating in the Kingston Heritage Days and did not request any electricity.

Action Item: Stacy D will bring to the select board meeting on Monday 8/7/23 to determine if and how the electricity updates will be paid.

f) **Social Media:**

Stacy D reported that the Kingston Days FB page and Instagram page are still not connecting. All posts will have to be done separately.

Action Item: Stacy D will send Rob a list of social media posts needed.

Boston Media North- Stacy G reported that a full-page ad will cost 350.00 and a half -page ad will cost 175.00. The ads will be placed in 3 different newspapers for this price.

Stacy D discussed that a half page ad should be placed for the Corn hole tournament and Scare Crow contest on August 17th, 24th and 31st and a full page ad for the same on 9/7/23.

Stacy D reported that there are currently 20-25 crafters that have paid for their booth. 15 non-profits and 5 sponsors that have tables.
