POLLS CLOSED AT 6:45 P. M.

Meeting called to order at 8 p. m. for purpose of voting on the articles in the Warrant:

ARTICLE II. Voted that the Town raise and appropriate the sum of \$6,610.07 to defray Town Charges for the ensuing year.

ART. III. Voted that the Town authorize the Selectmen and Treasurer to borrow a sum not to exceed \$10,000.00 in anticipation of taxes.

ART. IV. Voted that the Town accept State Aid for road construction—the State to pay \$2,312.00 and the town to raise \$1,156.50 and that any unexpended balance be applied on the Powwow River road.

ART. V. Voted that the Town raise and appropriate the sum of \$1,400.00 to tarvia the following roads: Newton Jct. Road, from the Newton Line to Whittier's Corner; Bartlett St.; West side of Plains; West and So. Kingston Road from Bartlett's corner.

ART. VI. Voted that the Town raise and appropriate the sum of \$500.00 for repairs on Little River Road (so called).

ART. VII. Voted that the Town raise and appropriate the sum of \$500.00 for permanent construction, extending from the previously constructed road, leading from Stella Cheney's corner toward Walter Bartlett's.

ART. VIII. Voted that the Town raise and appropriate the sum of \$150.00 for repairs and improvements on building

known as the Firemen's Hall, said repairs to be on the first floor.

ART. IX. Voted that the Town raise and appropriate the sum of \$400.00 for gravel and resurfacing on the Hunt road (so-called).

ART. X. Voted that the Town raise and appropriate the sum of \$100.00 for Memorial Day observance. The Moderator appointed Edward B. Clark and Beverly S. Chamberlain to serve as a committee.

ART. XI. Voted that the Town raise and appropriate the sum of \$200.00 for the purchase of dishes and silverware to be used in banquet room of the Town Hall. Warren G. Bakie was appointed as a committee to purchase same.

ART. XII. Voted that Town discontinue the road leading from New Boston Road to East Kingston, commonly known as the Phil. Rowell Road.

ART. XIII. Voted that the Town raise and appropriate the sum of \$300.00 each year for the purchase of new equipment and replacement of same for the Fire Dept. Said sum to be spent under the supervision of the Fire Wards.

ART. XIV. Voted that this Article be indefinitely postponed.

ART. XV. Voted that the Town authorize the Tax Collector to sell taxes to individuals at public auction as well as to the Town.

ART. XVI. Voted that the Town raise and appropriate the sum not to exceed \$5,000.00 for the purchase of a new tractor and snow plow; said tractor to be used only for snow removal and breaking of roads.

Committee appointed to purchase same to be—Howard C. Page, George B. Stevens, Walter Whittier and Roland Cheney. Payment for said tractor and snow plow to cover a period of three years, payable one-third each year.

ART. XVII. Voted that the Town raise and appropriate the sum not to exceed \$250.00 to paint the wood work on the Town Hall, the work to be done by local painters at the lowest bid. The Town to buy the paint.

ART. XVIII. Voted that the Town raise and appropriate the sum not to exceed \$250.00 for permanent improvement of the highway, known as Church Street, leading from the Congregational Church to the tarvia road near the residence of Levi S. Bartlett.

ART. XIX. Voted that the salary of \$100.00 per year be paid the Town Relief Agent.

ART. XX. Voted that the Town raise and appropriate the sum of \$1,200.00 for breaking of roads.

ART. XXI. Voted that any balance remaining from painting the Town Hall be used on the Firemen's Hall as per recommendation of the Finance Committee.

Voted that the Town Treasurer's salary be increased to \$100.00 per year.

Voted that taxes be discounted 3% if paid by June 1st.

Voted that all money appropriations for library expenditures be turned over to the Library Treasurer and he or she will pay all bills upon approval and signatures of board of trustees and he or she will render a report in detail of all expenses in Town Report.

Voted to adjourn at 10:45 P. M.

*To the inhabitants of the Town of Kingston, County of Rockingham in State of New Hampshire, qualified to vote in Town affairs:*

You are hereby notified to meet at the Town Hall in said Kingston on Tuesday the twenty-second day of May next at 8 o'clock in the evening to act upon the following subjects:

ARTICLE I. To see if the Town will vote to express its sentiment in regard to operating clocks one hour ahead of regular standard time, and setting its private clocks accordingly.

ART. II. To see if the Town will vote to extend the time from June 1st to August 15th in regard to a recent motion passed on March 13, 1934, regarding discounting of taxes.

ART. III. To see if the Town will vote to give the Selectmen the power to lease or rent the building known as the Granite State Shoe Shop.

ART. IV. To see if the Town will vote to raise a sum not to exceed \$1,100.00 for repairs on building and/or heating system, and general expense and transportation relating thereto, on building known as the Granite State Shoe Shop.

ART. V. To see if the Town will vote to close the Road known as the Towle Rd., leading from West Kingston to the residence formerly known as the Frye place in Kingston.

ART. VI. To transact any other business that may legally come before said meeting.

*To the Inhabitants of the Town of Kingston, in the County of Rockingham, in said State, qualified to vote in Town Affairs:*

You are hereby notified to meet at Kingston Town Hall, in said Kingston, on Tuesday, the thirteenth day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing by Australian ballot, the polls to close at 6:45 P. M. for voting purposes, and other articles in the warrant to be taken up at 8 o'clock P. M.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.
3. To see if the Town will vote to authorize the Selectmen and Treasurer to borrow a sum of money not to exceed \$10,000 in anticipation of taxes.
4. To see if the Town will vote to accept State Aid for road construction, the Town to raise \$1156.50, the State to pay \$2312.
5. To see if the Town will vote to tarvia, patch and repair the Newton Junction Road from the Newton Line to Whittier's Corner; Bartlett Street; west side of the Plains; and West and South Kingston Road, from Bartlett's Corner, and make an appropriation for the same.
6. On petition of Arthur Judkins and others: To see if the Town will vote to raise and appropriate the sum of \$800. for repairs on Little River Road, so-called.

7. On petition of Elmer A. Collins and others: To see if the Town will vote to raise and appropriate the sum of \$800 for permanent road construction extending from the previously constructed road leading from Stella Cheney's Corner toward Walter Bartlett's.
8. On petition of John Goodwin and others: To see if the Town will vote to raise and appropriate the sum of \$150, for repairs and improvements on the first floor of the building commonly known as the Firemen's Hall.
9. On petition of William Sjostrom and others: To see if the Town will vote to raise and appropriate the sum of \$600 for gravel and resurfacing on the Hunt Road, so-called.
10. To see if the Town will vote to raise and appropriate the sum of \$100 for Memorial Day observance.

19. To see if the Town will vote a salary for the Town Welfare Relief Agent, and make appropriation for the same.

20. To see if the Town will vote and raise and appropriate the sum of \$1200 for the breaking of roads.

21. To transact any other business that may legally come before said meeting.
