Eversource R11 Lot 11

All American Assisted Living R34-71B

There is a plan for an assisted living facility on the corner of Maine street and Rt. 125. The only thing we were given was an architect's rendering of the site. It is an advertising piece. Not enough information to comment on.

Ingalls LLA Hunt Road R6 14-1 & 14-2

This is a lot line adjustment. Comment needed about the driveway. Is it going across the wetlands?

DES NH DOT file#2044-00763 Plaistow-Kingston

Approval notice for permit for construction on Rt. 125. Mitigation will be 80.8 including 2 acres of wetlands. Question is: does this go to Kingston -Plaistow or the state aquatic resource mitigation fund? Seemly it goes to the state.
