Kingston, New Hampshire Board of Selectmen Meeting of December 30, 2021 Special Meeting: Encumbering of 2021 Funds FINAL MINUTES

The meeting was called to order at 12:12 PM in the Meeting Room at the Town Hall.

PRESENT: Vice Chair Richard Wilson; Electra Alessio, Donald Briggs, Kevin St. James (via Zoom software), Select Board Members.

The Board reviewed the list of expenses eligible to be encumbered from 2021, prepared by the Finance Director (see attached).

Selectman Wilson brought forward the request for a new computer at the historical museum, for which an estimate from Block 5 and a purchase order had been submitted about two months ago. He said this had been approved at a prior meeting by the three Selectmen present, contingent upon there being enough money left in the computer maintenance line. He said at the time there was \$7,500 left, and the computer will cost \$1.887.16.

SECOND: by Selectwoman Alessio

There was a discussion of the computer needs of the museum, and what is included in the cost of this computer; Selectman St. James said he wants to be sure the town is not over-buying. Selectman Wilson said the computer is what was recommended by Block 5, and that he had checked pricing and found it to be competitive.
