

**Kingston, New Hampshire
Board of Selectmen
Meeting of November 14, 2011
MINUTES**

The meeting was called to order at 7:02 pm in the Main Meeting Room of the Kingston Town Hall. In attendance were Chairman Peter Broderick and Selectman Charles Hart.

Police Department Grants Accepted

Police Chief Donald Briggs advised that his department has been awarded two Highway Safety Agency Grants, each of which is for \$5,407.50 and will cover the cost of 30 four-hour shifts between the dates of November 1, 2011 and September 15, 2012, for speed enforcement and DUI patrols.

MOTION: Upon motion of Selectman Hart and second of Chairman Broderick, it was voted to accept a Highway Safety Agency grant in the amount of \$5,407.50 for the purpose of funding Police Department speed enforcement shifts.

MOTION: Upon motion of Selectman Hart and second of Chairman Broderick, it was voted to accept a Highway Safety Agency grant in the amount of \$5,407.50 for the purpose of funding Police Department DUI patrols.

Chief Briggs advised that a total of \$165,665.50 in grants and donations has been awarded to his department so far in 2011.

It was agreed that review of a proposed Regulation for Pawn and Secondhand Dealer shops will be held at the November 21, 2011 meeting.

Plan Recording for Fire Station Property Approved

Because a Motion to Quiet Title on the Fire Department property on Main Street recently was granted by the Rockingham County Superior Court, the Board approved having the plan, prepared by Paul Nichols, PE, LLS, recorded at the Registry of Deeds. Mr. Nichols will be requested to prepare a mylar of the plan for recording.

Notice of Violation Reviewed and Signed

The Board signed a Notice of Violation for a Main Street property that is determined to have an excess of apartment units.

Inspection Report on Private Land Violation Complaint Reviewed

The Board reviewed a complaint received concerning alleged violations on a Drew Lane property and the inspection report prepared by Health Officer Larry Middlemiss who investigated the complaint. The Board will be taking no action at present; a reply letter to the complainant will be sent.

Country Pond Water Level Discussed

A letter from a resident in the Country Pond area concerning the water level and need to draw down was discussed. A copy of the letter has been provided to the Road Agent.

Review of Previous Meeting Minutes
